Introduction

The Sisters of Mercy Outreach Scholarships are funded by the College. The scholarships seek to offer places to students who will contribute to the richness and diversity of the College's community. The Sisters of Mercy are committed to the Mercy core values of respect, integrity, justice, compassion and service. The College honours and respects the links between the Sisters of Mercy and our College's history.

Criteria

- The scholarship is awarded to students whose financial circumstances mean they would find it difficult to attend or complete their secondary education at Mount St Bernard College.

Process

- Applications must be received by end of Term 3, 2023.
- Applicants who are short listed, will be notified and asked to meet with the Principal for an interview.
- All applications are handled confidentially due to the sensitive nature of financial circumstances that are involved for the applicants.
- Data supporting financial need is to be supplied with the application to the Business Manager of the College.
- The scholarship will be awarded at the discretion of the Principal. No award shall be made if, in the opinion of the Principal, no candidate is of sufficient merit.

Award

- The scholarship will entitle the successful applicant/s to 50% discount on tuition fees for their secondary education.
- Two scholarships are awarded per annum. One for an internal student and a second for an external student.
- An annual review of successful recipient/s will occur in December each year so that satisfactory progress is maintained.

Expectations

- The successful applicant/s may be asked to speak at a College assembly or gathering as a scholarship recipient.
- The successful applicants will be photographed and acknowledged in the College publications and on the website.
